Adopt an ordinance of the City of San José amending the following sections of Title 20: part 9.75 and 9.76 of Chapter 20.80; Table 20-90 of Chapter 20.40, Table 20-110 of Chapter 20.50, Table 20-138 of Chapter 20.55, Table 20-140 of Chapter 20.70, Table 20-156 of Chapter 20.75; Part 13 of Chapter 20.100. These amendments would allow Cannabis retail storefront (dispensary) in the Commercial Zoning districts, disallow a Cannabis dispensary in Industrial Zoning districts, change distance requirements from Cannabis businesses to sensitive uses with special consideration for the Downtown and Urban Village areas, allow a Zoning Verification Certificate Letter to expire, and make other technical, non-substantive, or formatting changes within those sections of title 20 of the San José municipal code (Citywide).
