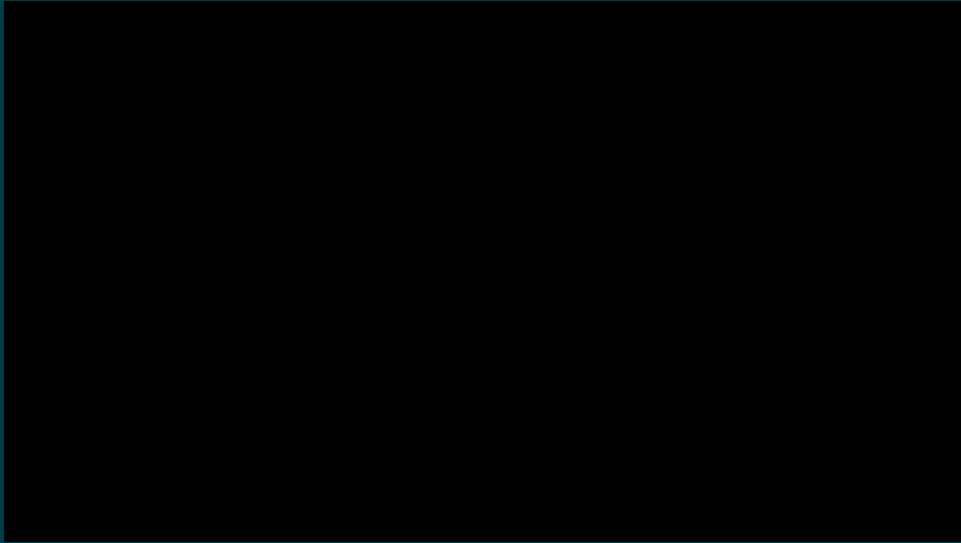


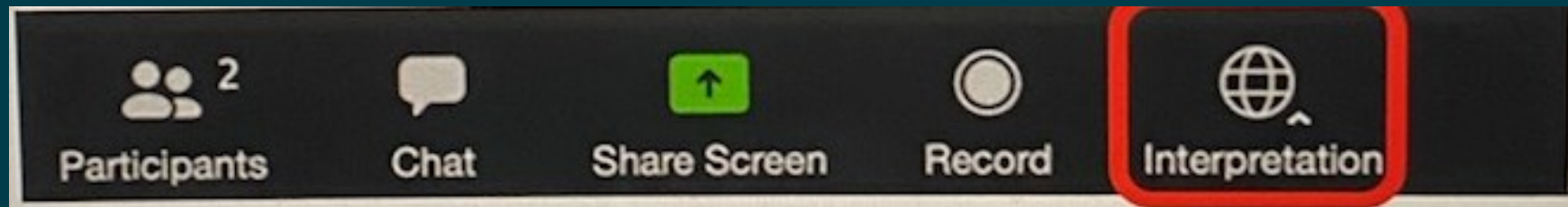

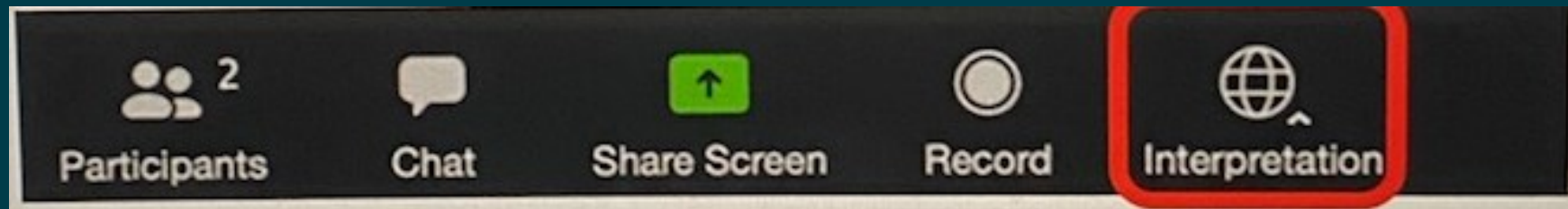

City Response Deep Dive | Small Business Recovery

What Has Changed?

- OEDCA work pivoted 95% to small business recovery
- Impact and recovery of 60K small businesses uneven
- Technical assistance services ecosystem is critical to recovery
- Federal, State funds not easily accessible

What is Driving Change?

- ARPA funds enabling personal, printed, multi-lingual outreach: biz walks, webinars, hotline
- Building capacity with TA partners, local associations
- Leveraging Federal & State resources – IRS, California Controller's Office

What is New?

- Direct financial assistance: grant programs
- Boost Biz S.J.: PBIDs, commercial corridor support, organizational capacity building, storefront grants
- 2 new bilingual staff; increased language capacity in communications
- Small business displacement policy planning
- Quetzal Gardens Small Business Center
- Revamp of BusinessOwnerSpace
- Technical assistance resources focused on East and Central San Jose, Downtown

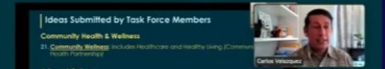

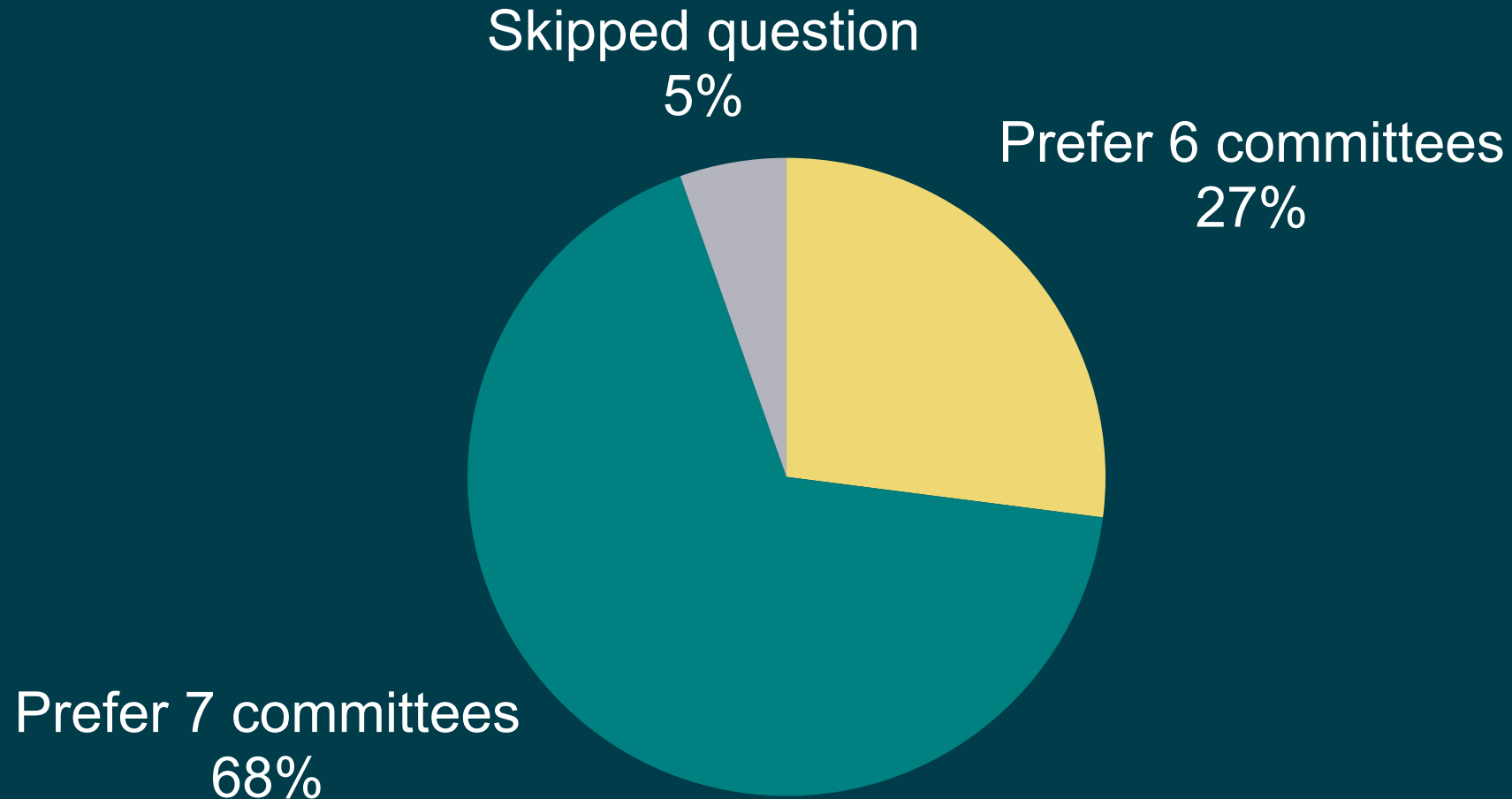

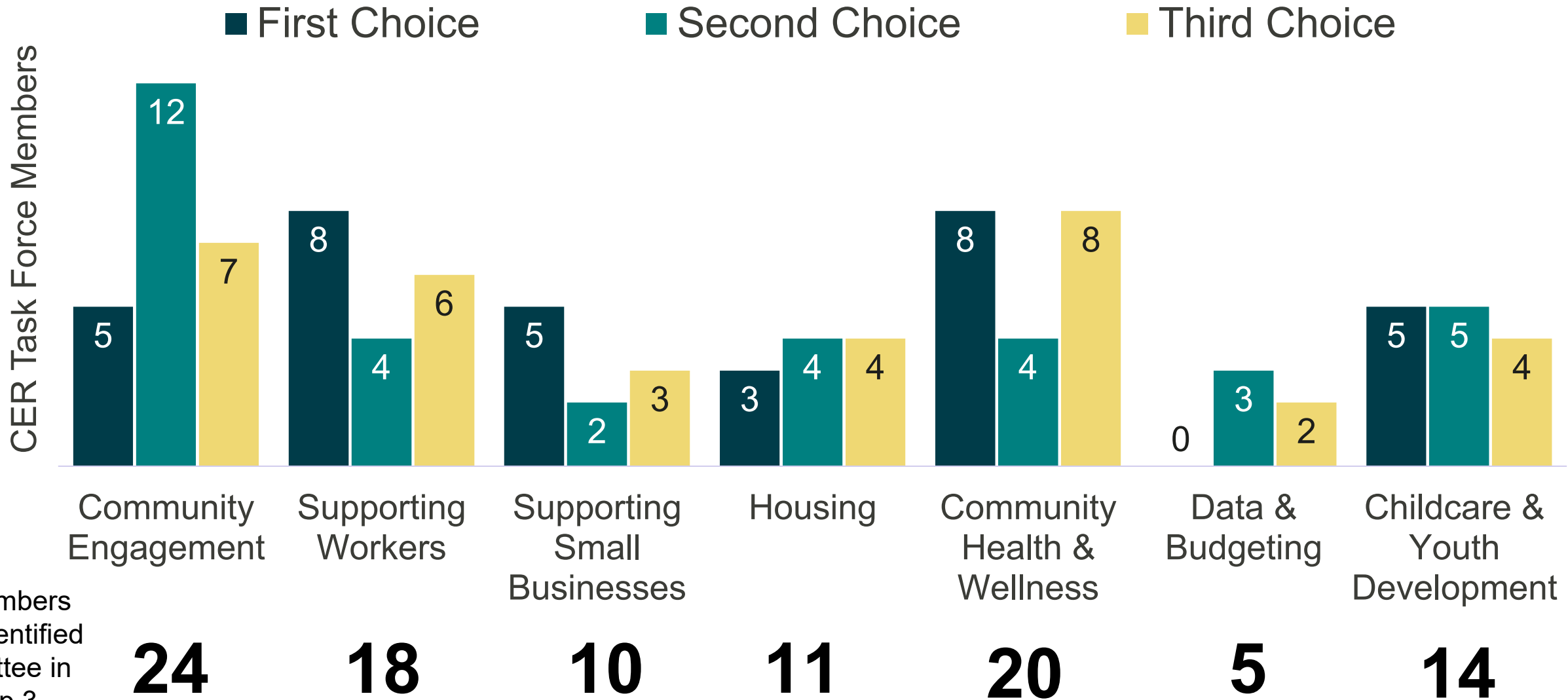

Survey Results: Recovery Task Force Committees Comments

Recent SCCOE report shows that the #1 reason people were looking for childcare was employment and #2 was seeking employment. Childcare & youth development and supporting small businesses are not a want, but a need

Consider the following to fit under other topics: 1) Support for minority businesses and put people back to work; restore businesses and put them back in place. 2) Discuss economic and financial impacts on our community (rent, utilities, etc.) and finding solutions. 3) Funding apprenticeship programs for students not going to college (plumbing, construction, entrepreneurship, etc.)

...assist in the recovery efforts for the hospitality industry... preserving (and potentially expanding) the funds available for marketing and developing travel to San Jose is essential

Incorporating art and culture to the workers' support committee is not a good idea; it is more connected to the Community engagement committee

We request creation of the following two committees, which we previously proposed but were not included in the subcommittee list distributed last week:

1. **Workplace Health, Safety, and Rights:** How can San Jose promote workplace health, safety, and justice to help ensure a full and fair return to work for San Jose businesses and workers?
2. **Just Recovery for Airport & Hotel Workers:** How can workers, the City, Team San Jose, San Jose Airport, hotel employers, and other stakeholders come together to ensure that airport and hotel workers are included in recovery, and that we are preserving and expanding on the assets and experience of our local workforces to enable the hospitality sector to rebound?

We also suggest that a separate workforce development committee be created, if there is interest from other Task Force members in focusing on workforce development and job training.

In addition, based on comments made at the January Task Force meeting, it may be that other Task Force members may want to bring forward subcommittees they had proposed, and which they may not feel reflected in the current structure. A more democratic process to choose committees might be a vote or poll among the committee ideas as originally proposed by Task Force members.

Thank you for your consideration. We look forward to working collaboratively to pursue a recovery that moves us towards a more equitable and resilient San José.

 - Review existing data, services, and resources included in City's COVID-19 Recovery Initiatives and help connect residents to resources
 - Identify any gaps/suggest actions to address needs
 - Compile preliminary findings and potential action items to inform City's budget process (April)
 - Compile feedback from community engagement
 - Develop action items for full Task Force to consider and include in final report to City Council
