SUBJECT: EFFECTIVE FEBRUARY 25, 2022 THE CITY OF SAN JOSE IS REDUCING EMERGENCY OPERATIONS CENTER ACTIVITIES

In May and June of 2021, the Administration and City Council finalized the planning and budgetary resources to transition the organization from COVID-19 Emergency Response—with a fully activated Emergency Operations Center (EOC)—to the beginning of Community and Economic Recovery. Yet, due to the unexpected and unplanned local emergence of the Delta variant in July 2021 creating the "4th wave" of the pandemic, the associated ability to infect 2.5x the number of people as the original strain, and the dramatic increase in transmissions and infections, the City again reactivated the EOC to ensure that response, recovery and other items on the City Roadmap could occur in parallel.¹ Since August 2021, the EOC has continued to operate focusing on our local response to the Delta and Omicron variants.

- 1. Effective February 25, 2022, the EOC will reduce operations. This is based on case counts from the current Omicron surge that have dropped dramatically and are expected to continue to drop over the coming weeks;
- 2. As the most vaccinated big city in the country, we have, throughout the duration of the existing emergency, expanded resources to respond to surges while maintaining a comparable level of services;
- 3. Our existing policies and procedures in place around workplace safety, including masking and vaccinations, are enough to ensure continued operation and can be modified to stay in line with County Guidance as the situation changes without the EOC being fully activated;
- 4. The City Roadmap provides an effective governance structure for ongoing recovery work that is not dependent on the EOC;
- 5. The EOC will remain staffed at a level to continue appropriate monitoring of the emergency situation and can immediately recommend expansion of the EOC if necessary, to manage any new emergency response; and

6. The City's Proclamation of Local Emergency will remain in effect to enable staff to support ongoing food services, digital equity, housing stabilization, vaccination/testing support, and other extraordinary services the City assumed to ensure the public health of our residents. When conditions warrant termination of the Local Emergency, we will return to City Council for such action.

All ongoing recovery operations will shift back to the appropriate departments as part of the City Enterprise Priority COVID-19 Pandemic: Community and Economic Recovery led by Deputy City Managers, Rosalynn Hughey and Rob Lloyd. The Vaccination Taskforce will also remain in effect and continue to operate as part of the City Manager's Office of Emergency Management under Director Raymond Riordan. A chart of the current City Roadmap with initiative leads is included as an attachment to this memorandum for reference.

We will continue to regularly report to the City Council on our COVID-19 Community and Economic Recovery efforts as the work of implementing City Roadmap items come to the City Council or a City Council Committee for updates, discussion, or action. As the mechanism for communication, these reports will now primarily be heard through items on the regular agenda rather than through the Report of the City Manager (Council Agenda, Item 3.1). Because the 200 flash reports issued from the EOC (available in English, Spanish, Vietnamese, and Chinese (simplified and traditional)) have been so well received, the City Manager's Communications Office is in the process of developing a transition plan for those reports in order to continue engaging our residents and businesses during the extended recovery.

As the City reduces activity in the EOC, it is important to note that the health and safety of City employees and our community remain a top priority. As such, departments will continue the COVID-19 safety liaison's functions and coordination with the Human Resources Department safety team (e.g., responding to positive COVID cases, exposures, notifications, quarantines).

The Office of Emergency Management will now shift focus to the After-Action Review of our COVID-19 Pandemic response and the planning, preparation, and training required to ready us for the next set of threats and hazards, including the goal of making sure we are quake ready for the inevitable "Big One."
