#### a) Voting Procedures and Rosenberg's Rules of Order Training.

This item was taken out of order, after item VIIb. The City Clerk provided a training on Rosenberg's Rules of Order and voting procedures. The Commission decided that each Commissioner will limit their speech to three minutes during discussion, with the

understanding that the time limit may be extended in the case of completing a thought. The City Clerk reviewed Resolution No. 79867 to highlight the specific rules which govern the Redistricting Commission.
