(B. Madrid, Housing Development)

Commissioner Partida made the motion, HCDC recommends that the Lived Experience seat be expanded to 2 seats, with at least 1 person that identifies as female. Lived experience should be recent, within the last 3 years, with a second by Chair O'Connell. The motion failed 5-5.
