SUBJECT: FY 2022-23 CULTURAL FUNDING PORTFOLIO – PERCENTAGES FOR FUNDING LEVELS

RECOMMENDATION

Forward a recommendation to the Arts Commission that the Fiscal Year (FY) 2022-23 Operating Budget for the Cultural Funding Portfolio reflect the following recommended guidelines for percentage levels, subject to available funding: 77.25% for the *Operating Grants*, 14.00% for *Festival, Parade and Celebration Grants*, and 8.75% for *take pART* Grants.

BACKGROUND

Fifteen percent of the collected Transient Occupancy Tax (TOT) is traditionally used for the funding of cultural arts grants, other programs, and operations of the Office of Cultural Affairs (OCA). Available funding is based on projected TOT funding for the upcoming fiscal year.

The amount of additional funds to supplement TOT funding have not yet been specified. Therefore, it is recommended that the Arts Commission approve recommended percentages for funding levels in the three core grant programs, rather than specific amounts. These recommended percentages can then be applied to the most accurate budget estimates which will be available towards the end of the fiscal year.

The benefit of recommending percentage allocations rather than fixed dollar amounts is that it allows the final grant recommendations to be based on the most up to date TOT projections, rather than early projections which can be subject to change. In prior years when percentages were not used, published grant panel recommendations had to be adjusted several times based on revised TOT projections and available augmentation funding, making planning difficult for applicants.

Through the establishment of the proposed percentages, staff can proceed with the peer review panel process to develop recommendations for grant awards which contain the latest TOT

projections in time for the Arts Commission review at its May meeting. The recommended grant awards will be forwarded to Council as part of the FY 2022-23 budget process.

ANALYSIS

The largest annual arts and cultural grant programs include: Operating Grants (OpG); Festival, Parade and Celebration Grants (FPC); take pART grants; and the Capitalization and Sustainability grants. Introduced three years ago, the Capitalization and Sustainability grant program has been funded at \$200,000 per year for initiatives that promote the stability of midand large-size budget arts organizations, which are the source of the greatest employment and highest economic impact in the arts ecosystem.

The recommended percentages allocations above are based on 1) a priority for the Operating Grant Program that sustains the majority of arts organizations with full-time professional staff and year-round programming for the community; and 2) trends in the distribution of applications within the three largest grant programs. After setting aside \$200,000 for continued support of the Capitalization and Sustainability Grants, these percentages will be applied to the total amount of available funding for the Cultural Funding Portfolio, including any recommended grant augmentation amounts from the TOT Long Term Reserve if applicable. If there are funds remaining in one grant program after final recommendations are calculated, the remaining amounts will be redistributed to other grant programs, consistent with priorities expressed in the original allocations.

The recommended percentages for FY 2022-23 are changed from the prior years. The OCA takes a fluid approach to its recommended portfolio distribution based on applications across programs. In this upcoming FY cycle, there is a redistribution that emphasizes the *take pART* program due to previous OpG grantees applying in this program.

Development of Grant Award Recommendations

Because definitive funding amounts will not be available in time for the panel review meetings, the panels will be charged with ranking the applications and recommending funding percentages for each application, in lieu of specific funding amounts. When proposed grant funding amounts are available, staff will apply these funding percentages to determine the proposed grant amount

for each application. If necessary to conform to final funding allocations, minor adjustments will be made following the relative proportions initially recommended by the panel.

When the panel recommendations are presented to the Arts Commission at its regular May meeting, the grant recommendations will reflect the amount of available TOT funding for arts grants in the proposed FY 2022-23 Operating Budget. Staff will evaluate TOT projections to determine whether TOT Long Term Reserves will be recommended for use to provide stable funding. Because the budget is based on TOT projections, the Variance Contingency is utilized to cover shortfalls of up to 10 percent in TOT revenues received, measured against TOT revenues projected. This long-standing budgeting practice reflects prudent planning to minimize any destabilization among grantees should the TOT be lower than estimated in the next fiscal year. At the May meeting, it will be recommended that the Commission forward a recommendation to the City Council to approve the full grant awards, as part of City Council's adoption of the FY 2022-23 Operating Budget.

The final amount of recommended grant funding will be by the following calculation:
