Thank you Richard for keeping the goals and mission for SJCE on the table. I think the Bryce article's reference to the recent CPUC decision is particularly relevant.

What is important in my view is that SJCE has to operate and make investments within these CPUC requirements (and others), and these policy prescriptions overlap with SJCE's mission. Should SJCE settle for meeting environmental goals required by law or should it strive to do more? This question is up to the Council, hopefully with the informed guidance from the CECAC and SJCE staff.

At the next CECAC meeting I propose the CECAC consider forming a new ad hoc committee to review and summarize the environmental performance requirements imposed by the CPUC, CARB, and the CEC, and any other governing entities. The committee would be charged with reporting back to the CECAC a summary of these requirements, and the implications for SJCE's future procurement in meeting these legal requirements and the City's Carbon-Free goals. It should also address the opportunities for providing incremental environmental value beyond what is required by law.

I hope we can discuss this as part of item VII. D of next week's agenda (Discuss potential CECAC next steps for staff feedback on Ad Hoc Committee Memo and Executive Summary).
