The San José Housing Department is pleased to provide this notice of **Proposed Spending Priorities for the FY 2022-2023 Annual Action Plan**. Annual Action Plans oversee the City's use of federal funds from the U.S. Department of Housing and Urban Development (HUD). After spending priorities are determined, the draft FY 2022-23 Annual Action Plan will be made available for public comment on the Housing Department's website from April 1, 2022, through May 1, 2022. We welcome public comment, and all public comments will be submitted to HUD.
