## SUBJECT: REPORT ON ACTIVITIES UNDERTAKEN BY THE DIRECTOR OF AVIATION UNDER THE DELEGATION OF AUTHORITY ORDINANCE FOR THE PERIOD OF JANUARY 1 – MARCH 31, 2022

#### **EXECUTIVE SUMMARY**

The San José Municipal Code authorizes the Director of Aviation to negotiate and execute Agreements, Permits, Licenses and Leases on behalf of the City. In accordance with the Municipal Code's reporting guidelines, this memorandum details actions taken under the delegation of authority to the Director of Aviation for the third quarter of FY 2021-2022 (January 1 - March 31). During this reporting period, the Director of Aviation approved actions to execute: one hanger lease amendment, two airport premise lease agreements and amendments, two small concession agreements and amendments, and five ground transportation permits.

This activity is summarized in Attachment A.
