RECOMMENDATION

Recommend that the City Council approve the proposed FY 2022-2023 *take pART* Grant awards as specified in Attachment A and subject to the availability of funds appropriated in the City's FY 2022-2023 Operating Budget.

BACKGROUND

The *take pART* Grants are a support resource for specific arts activities offered by non-professional arts organizations and community service organizations with continuing arts programs, as well as very small semi-professional and professional arts organizations seeking to secure City support for specific arts activities, rather than general operating support.

take pART Grants are intended to encourage:

- Opportunities for public participation in arts and cultural activities;
- Life-long arts and cultural education programs outside the school setting;
- Expressions of culturally-specific traditions of San Jose's diverse population;
- Opportunities to experience the arts in neighborhood and community settings; and
- Programs that serve the needs of the clients of health and social service institutions.

The *take pART* program is a competitive grants program. Prior success in receiving a *take pART* Grant award is no assurance that an organization will be awarded a grant in any given year.

ANALYSIS

The Office of Cultural Affairs (OCA) received 22 eligible applications in the FY 2022-2023 cycle of *take pART*. The applications included grant requests ranging between \$3,000 and \$15,000, the maximum possible individual grant amount in the program.

The Grant Review Panel met on March 24 & 25, 2022 to complete its evaluation of the *take pART* grant applications. The five-member panel considered each application against the four evaluation criteria established in the grant program guidelines: Project/Program Quality (40%); Organizational Capacity (30%); Appropriateness of Budget/Grant Request (20%); and Community Impact (10%).

The panel was comprised of the following experienced arts management professionals and a representative of the Arts Commission:

- Tamara Alvarado, Program Officer, David & Lucile Packard Foundation
- Sarah Billings, Street Life Plan Manager, San José Downtown Association
- Valeria (Val) Miranda, Executive Director, Santa Cruz Art League, and Pajaro Valley Arts
- Ben Miyaji, Palo Alto Public Arts Commission
- Lynne Rosenthal, San José Arts Commissioner

Overall scores for the 22 applications ranged from a high of 92.5 to a low of 62.0, out of a maximum of 100. The panel considered applications with similar scores by clusters. Due to the City's pending development of the proposed Operating Budget for FY 2022-2023, the panel did not have specific dollar amounts to recommend for distribution at the time of its meeting. Instead, the panel made recommendations for approximate funding percentages, to be adjusted proportionally, when the final amount for distribution was available.

The panel recommended funding for 21 of the 22 eligible applications based on the ranking of their scores in each budget category. The percentage recommendations were translated into actual dollars after the specific funding amount was available. Given an increase over the previous year's funding for the *take pART* grants, adjustments to recommended percentages and specific dollar amounts were made that take into consideration panel evaluation/scoring, total funding available, and sustainability of program support over time.

At its March 21, 2022 meeting, the Arts Commission recommended that 8.25% of the available funds in the Cultural Funding Portfolio be allocated to the *take pART* program. This recommendation results in \$322,333 being available for *take pART*. The recommended percentages for *take pART* for FY 2022-23 are changed from the prior years. The OCA takes a fluid approach to its recommended portfolio distribution based on applications across programs. In this upcoming FY cycle, there is a redistribution that emphasizes the *take pART* program due to previous Operating Grant grantees applying in this program. The recommendations are contained in Attachment A.

The Executive Committee reviewed these recommendations at a publicly noticed meeting on May 2, 2022. Notices of granting opportunities were distributed to the OCA's e-mail contacts lists, posted on the OCA website, uploaded on the City of San Jose WebGrants platform, and shared via social media.

ATTACHMENT B: FY 2022-2023 take pART Grants Project Descriptions

Alliance for Youth Achievement

Grant will support the Art & Design Thinking Camp, an adventure in making and imagining. This project-based camp engages middle school youth in exploring design thinking processes, digital tools, and visual arts with a focus on arts and culture. There will be nine weeks of camp in 2022-2023. The full day summer camp will run from July to August 2022.

American Beethoven Society

Grant will support bringing the world-renowned, Grammy award-winning Takacs String Quartet to Downtown San José for two public events: a concert on February 16, 2023, and a lecture-recital the following day, with both events taking place at the San José State University Concert Hall.

Chamber Music Silicon Valley

Grant will support the 10th Annual Silicon Valley Music Festival on August 18-28, 2022 at San José Museum of Art's Circle of the Palms in Downtown San José. Over the course of ten days, five concerts and two youth workshops will be presented at Mexican Heritage Plaza serving a projected audience of 500.

Chopsticks Alley Art

Grant will support the creation of a Vietnamese American theatrical production in San José adapting famous and beloved Vietnamese folktales, myths, or legends. The play will be geared toward elementary school-age children and families. Inaugural performances will take place over the course of two weekends in February 2023, coinciding with Vietnamese Lunar New Year celebrations.

La Raiz Magazine (Fiscal Sponsor: School of Arts & Culture @ MHP)

Grant will support La Raiz Magazine's six art and poetry workshops and four showcases in the community between July 2022 and June 2023. All events will be free to the public and promote work by women and BIPOC. Creative work will be collected from participants to be considered for digital and print publication.

More Mas Marami

Grant will support the production of *Dear Kitty, Querida Ana* by local playwright Enrique Muñoz in Fall 2022. This production will also feature a series of workshops for youth, and an audience tool kit to engage with the issues presented.

Mosaic America

Grant will support Mosaic America in collaboration with various community partners will curate and present a series of four free, place-based, intercultural arts performances, conversations and food that are designed to authentically include and celebrate San José's cultural diversity and foster a sense of community and belonging.

Opera Cultura

Grant will support the world premiere of Hector Armienta's chamber opera, La Muerte, at the School of Arts and Culture on May 13th, 14th, & 15th. Students (ages 16 - 22) from Opera Cultura's La Escuela program will perform alongside professional opera singers.

Positive Alternative Recreation Teambuilding Impact (P.A.R.T.I.)

Grant will support four cohorts, two months each, of African American historical stepping, Polynesian dance, and four youth led community events which include youth painting and drawing exhibits. Cohort 2022-23 launch dates: June, September, January, and April. 2022-23 Event dates: July, October, February, and May.

Playful People Productions

Grant will support the production of the challenging, hilarious, and poignant play, *She Kills Monsters*, by Qui Nguyen, at the Historic Hoover Theater in San José in Spring 2023. Expected eight performances before an audience of approximately 120 each performance for a total of approximately 960 attendees.

Red Ladder Theatre Company

Grant will support Imagination Ignited - Creative engAGEment with Japantown Seniors is intended to provide an opportunity for seniors in San José's Japantown neighborhood to connect with their creativity and, using the tools of theatre, tell stories of their own devising. A total of three sessions of twelve workshops (36 total workshops) will be take place throughout 2022-23.

Santa Clara Valley Performing Arts Association (Mission Chamber Orchestra)

Grant will support The Santa Clara Valley Performing Arts Association presentation of Mission Chamber Orchestra in a season of live classical orchestral music in San José between September 2022 and May 2023.

San José Center for Poetry and Literature (Poetry Center San José)

Grant will support poetry and spoken word community engagement projects including Bauchaar, Beautiful Black Books, Well-RED Reading Series, Veterans of Life Write outreach, SCC Youth Poet Laureate, SCC Poet Laureate, Red Wheelbarrow Poetry Prize, publishing Caesura and workshops at Markham House throughout 2022-23.

San José Chamber Music Society

Grant will support San José Chamber Music Society's 36th season in 2022-23: a series of six public concerts of classical chamber music [one-on-a-part, no conductor] by top quality local, national, and international performing ensembles at St. Francis Episcopal Church in the Willow Glen area of San José.

San José Downtown Foundation

Grant will support Downtown Doors, an award-winning competition/exhibit for 2022-23. The program provides students real-life experience to express themselves publicly through art. The program also enlivens downtown's urban spaces. The Downtown San José community has enjoyed 320+ works from 25 schools on 115 sites for over 20 years.

sjDANCEco

Grant will support sjDANCEco's 20th Annual Fall Season of World Premieres and Revivals. sjDANCEco serves the community through innovative Professional Dance performances of the highest artistic caliber, community festivals and outreach.

South Bay Guitar Society of San Jose

Grant will support the presentation of five ticketed concerts in San José and take artists out to San Jose schools that have guitar classes, and five masterclasses to be given by guitar artists that perform the concerts.

To Be Empowered

Grant will support a year-long series of Latin dance instruction for children, youth, adults, and seniors. Classes will be held at Overfelt High School.

Vietnamese in San Jose

Grant will support preserving Vietnamese heritage and culture via the arts. Music and photography are the frequent highlights with competitions.

Winchester Orchestra

Grant will support four classical/Pops concerts at Lincoln Glen Church in San José. The concerts will be performed October 2022, December 2022, March 2023, and May 2023.

Works/San Jose

Grant will support a year-long series of community exhibitions and performances in an exciting new Downtown San José collaborative arts center, with additional gallery activations with partners at the Mexican Heritage Plaza.
