RECOMMENDATION

That the following recommendation be enacted.

Proposal

Program/Project Title: Martha Gardens Alleyways--Standard Improvement

Amount of City Funding Required: \$1,145,000

Fund Type (i.e. General Fund, C&C funds, etc.) <u>Storm Sewer Operating Fund</u> & <u>Construction Excise</u> <u>Tax Fund</u>

Anticipated Outcomes: Requested funding changes would affect benefits or services for San José residents, businesses, community groups, etc., as described below: (Use as much space as required.)

The Martha Gardens alleyways, located between S. 2nd and S. 3rd streets and Margaret and Martha Streets, have been neglected for a long time. Both alleyways are in extreme disrepair with potholes and little to no paving in most parts. The lack of proper drainage and stagnant water poses a health risk, becoming a breeding ground for mosquitoes that transmit diseases. The alleyway is the only way for drivers to access parking stalls and garages to homes on S. 2nd and S. 3rd Street. Staff has indicated that approximately 70% of the problem in the alleyways is storm drain related and can be covered with storm funds. Although staff is currently in the process of submitting a grant to the State to cover a slightly more expensive version of this proposal ("Green" Alleyway Improvement Project) I request that we allocate these funds in case we do not receive the grant funds. The funds are expected to be awarded in early 2013 at which time we can proceed with construction in the Spring of 2013.
