Mr. McGovern,

If you question is related to the campaign contribution limit for the run-off election, candidates and candidate controlled committees may raise a maximum of \$1,400 per person for the 2022 run-off, if applicable.

As for the disclaimer the "paid for by" disclaimer is still required. The rest of the disclaimer is not mandated under the San Jose Municipal Code. For information about City required disclaimers please visit here: https://www.sanjoseca.gov/your-government/appointees/city-clerk/elections/campaign-information-for-candidates.

Although the City Attorney's Office may provide information on State law as it relates to San José's ethics and election laws, the FPPC is ultimately responsible for interpreting its rules. Relying on advice from the City Attorney's Office is not a defense in an inquiry on whether State law has been violated.

Only citizens or legal U.S. residents may contribute.
