

Emergency Interim Housing (EIH)

Alternative Suggested Sites for Evaluation and Sites for Re-Evaluation - Council Districts 4 and 10

Important: This list represents sites that need evaluation and/or re-evaluation through the City’s EIH feasibility, viability and practicality process, and only those passing the evaluation can be recommended for EIH development. The list has been assembled from suggestions from the community, elected officials, other public agencies, and City staff. Being on this list only means that a site will go through evaluation. Most sites will not pass the evaluation process and will not be recommended for EIH development; only the most viable and practical sites would be considered for recommendation. The City anticipates issuing an evaluation update at the end of September and October, before making recommendations to City Council in late November.
