THE CITY OF SAN JOSÉ IS PROPOSING SUBSTANTIAL AMENDMENT TO ITS ANNUAL ACTION PLANS FROM FY 2022-2023. THIS NOTICE PROVIDES A SCHEDULE OF PUBLIC HEARINGS AND OPPORTUNITIES FOR PUBLIC REVIEW AND COMMENT.

The proposed Substantial Amendments updating the City's approved FY 2022-2023 AAP. The comment period for the Substantial Amendment runs from September 18, 2022 to October 18, 2022. This provides an opportunity for public input.

The AAPs govern the use of federal funds from the U.S. Department of Housing and Urban Development. The City's funds received by formula from HUD include Community Development Block Grant (CDBG), Emergency Solutions Grant (ESG), HOME Investment Partnerships (HOME), and Housing Opportunities for Persons with AIDS (HOPWA). The City's formula funds average approximately \$14 million annually, depending on the federal budget. The development of these Plans is significantly informed by public feedback

If you would like to provide comments on the Plan amendment, the City welcomes your attendance at any of the meetings listed in the schedule below. Additionally, comments may be provided by phone, regular mail (to the City of San José Housing Department, 200 E. Santa Clara Street, 12th Floor, San José, California 95113), or by email via the contact information listed below for both English speakers and those with limited English proficiency. The draft Substantial Amendments will be made available for public comment on the [Housing Department's website](#) from September 18, 2022 through October 18, 2022.
