## Energy and Water Building Performance Ordinance (BPO)

List of Qualified Service Providers

The City of San José's Environmental Services Department has prepared a directory of local qualified service providers. The service providers on this list have undergone an official review process stating that they meet the ordinance's specified requirements for performing auditing, retrocommissioning, or data verification for compliance with the Beyond Benchmarking requirements of the <u>BPO</u>. If you would like to use a service provider that is not included on this list, they must meet the minimum qualifications set forth in <u>Municipal Code 17.85</u> and their qualifications must be shared with the BPO team prior to your report submission.
