**NOTICE OF DETERMINATION
FOR A NEGATIVE DECLARATION**

Lead Agency: City of San José Department of Planning, Building and Code Enforcement

Project Title: Incidental Safe Parking Use Municipal Code Amendments

Project Description: Proposed amendments to Title 20 of the Municipal Code to create standards that could allow homeless individuals and families to sleep overnight in their personal vehicles, by allowing 'safe parking' as an incidental permitted use to an existing assembly use or on City properties, where the safe parking is provided on existing paved parking areas and operating in compliance with the San José Municipal Code.

Location: Citywide, San José

The City has performed environmental review on the project. Environmental review examines the nature and extent of any adverse effects on the environment that could occur if a project is approved and implemented. Based on the review, the City has prepared a draft Negative Declaration for this project. A Negative Declaration is a statement by the City that the project will not have a significant effect on the environment.

This is to advise that the City Council of the City of San José approved the above-described project on **February 26, 2019** and made the following determinations regarding such project:

1. The Initial Study and Negative Declaration referenced above was prepared and completed for this project pursuant to and in compliance with the provisions of CEQA.
2. The City Council has independently reviewed and analyzed the Initial Study and Negative Declaration and other information in the record and has considered the information contained therein, prior to acting upon or approving the Project.
3. The Initial Study and Negative Declaration represents the independent judgment and analysis of the City of San José, as lead agency for the Project.

4. This project will not have a significant impact on the environment.
5. Findings were made and adopted for this project pursuant to the provisions of CEQA.
