Trista,

Section 12.06.230 of the Municipal Code prohibits the acceptance of anonymous campaign contributions. Under subsection B, "All anonymous contributions must be surrendered to the director of finance for deposit in the general fund of the city, earmarked to defray the costs of municipal elections." The contributions should be turned over within 30 days of acceptance

I will defer to the Clerk's office to assist you with surrendering the anonymous contributions.
