



Annual Operational Permit Check List

January 2013

In addition to the **Required Construction Permits** which have been issued as a result of this approved review, **Operational Permits** are required for this project as well.

105.6 Required operational permits.

The fire code official is authorized to issue operational permits for the operations set forth in Sections 105.6.1 through 105.6.47 of the 2013 California Fire Code (CFC).

The following Annual Operational Permits will be issued by the San Jose Fire Department for this project upon Certificate of Occupancy being granted.

Req'd	Type Required operational permit(s)
	105.6.2 Amusement buildings. An operational permit is required to operate a special amusement building.
	105.6.3 Aviation facilities. An operational permit is required to use a Group H or Group S occupancy for aircraft servicing or repair and aircraft fuel-servicing vehicles. Additional permits required by other sections of this code include, but are not limited to, hot work, hazardous materials and flammable or combustible finishes.
	105.6.5 Cellulose nitrate film. An operational permit is required to store, handle or use cellulose nitrate film in a Group A occupancy.
	105.6.6 Combustible dust-producing operations. An operational permit is required to operate a grain elevator, flour starch mill, feed mill, or a plant pulverizing aluminum, coal, cocoa, magnesium, spices or sugar, wood finishing, or other operations producing combustible dusts.
	105.6.7 Combustible fibers. An operational permit is required for the storage and handling of combustible fibers in quantities greater than 100 cubic feet (2.8 m3).
	105.6.9 Covered mall buildings. An operational permit is required for:
	1. The placement of retail fixtures and displays, concession equipment, displays of highly combustible goods and similar items in the mall.
	2. The display of liquid- or gas-fired equipment in the mall.
	3. The use of open-flame or flame-producing equipment in the mall.
	105.6.17 Floor finishing. An operational permit is required for floor finishing or surfacing operations exceeding 350 square feet (33 m2) using Class I or Class II liquids.
	105.6.22 High-piled storage. An operational permit is required to use a building or portion thereof as a high-piled storage area exceeding 500 square feet (46 m2).
	105.6.24 Industrial ovens. An operational permit is required for operation of industrial ovens regulated by Chapter 21.
	105.6.25 Lumber yards and woodworking plants. An operational permit is required for the storage or processing of lumber exceeding 100,000 board feet (8,333 ft3) (236 m3).

	105.6.26 Liquid or gas-fueled vehicles or equipment in assembly buildings. An operational permit is required to display, operate or demonstrate liquid- or gas-fueled vehicles or equipment in assembly buildings.
	105.6.29 Miscellaneous combustible storage. An operational permit is required to store in any building or upon any premises in excess of 2,500 cubic feet (71m ³) gross volume of combustible empty packing cases, boxes, barrels or similar containers, rubber tires, rubber, cork or similar combustible material.
	105.6.34 Places of assembly. An operational permit is required to operate a place of assembly.
	105.6.35 Private fire hydrants. An operational permit is required for the removal from service, use or operation of private fire hydrants.
	105.6.39 Repair garages and motor fuel-dispensing facilities. An operational permit is required for operation of repair garages and automotive, marine and fleet motor fuel-dispensing facilities.
	105.6.40 Rooftop heliports. An operational permit is required for the operation of a rooftop heliport.
	105.6.41 Spraying or dipping. An operational permit is required to conduct a spraying or dipping operation utilizing flammable or combustible liquids or the application of combustible powders regulated by CFC Chapter 24.
	105.6.42 Storage of scrap tires and tire byproducts. An operational permit is required to establish, conduct or maintain storage of scrap tires and tire byproducts that exceed 2,500 cubic feet (71 m ³) of total volume of scrap tires and for indoor storage of tires and tire byproducts.
	105.6.44 Tire-rebuilding plants. An operational permit is required for the operation and maintenance of a tire-rebuilding plant.
	105.6.45 Waste handling. An operational permit is required for the operation of wrecking yards, junk yards and waste material-handling facilities.
	105.6.46 Wood products. An operational permit is required to store chips, hogged material, lumber or plywood in excess of 200 cubic feet (6 m ³).
	105.6.47.4 Battery system. An operational permit is required to operate stationary lead-acid battery systems having a liquid capacity of more than fifty gallons (189 L). <i>Added by SJ Ordinance 29349</i>
	105.6.47.5 Day care facility. An operational permit is required to operate any day care home or facility which provides day care for adults or children. <i>Added by SJ Ordinance 29349</i>
	105.6.47.6 High-rise buildings. An operational permit is required to operate any high-rise building. <i>Added by SJ Ordinance 29349</i>
	105.6.47.7 Institutions. An operational permit is required to operate any health facility as defined in Section 1250 of the California Health and Safety Code, with an occupant load of more than six persons, or to operate any jail or facility where personal liberties of the occupants are restrained. See California Code of Regulation Title 24 Part 2. <i>Added by SJ Ordinance 29349</i>
	105.6.47.8 Multi-story building. An operational permit is required to operate any building which is not a high-rise building, but has four or more floors. See Section 3.09 of Title 19 of the California Code of Regulations. <i>Added by SJ Ordinance 29349</i>
	105.6.47.9 Residential care facility. An operational permit is required to operate any residential care or service facility, as described in the Building Code, accommodating more than six persons. <i>Added by SJ Ordinance 29349</i>
