Site Development Permit to allow the construction of approximately 1.2 million square feet of office space within two commercial buildings on an approximately 3.09-gross acre site. Predominately office space at upper levels with ground floor active uses including flexibility for a mix of retail, entertainment, restaurants, and other publicly accessible spaces. The project includes the removal of 68 ordinance-size trees and 18 non-ordinance-size trees.
