SUBJECT: SIXTH SUBSTANTIAL AMENDMENT TO THE FISCAL YEAR 2019-2020 ANNUAL ACTION PLAN FOR THE REALLOCATION OF CORONAVIRUS AID RELIEF AND ECONOMIC SECRURITY ACT (CARES) FUNDS AWARDED BY THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) FOR ELIGIBLE USE

RECOMMENDATION

- (a) Hold a public hearing to allow for public comment.
- (b) Adopt a resolution relating to the following actions regarding a sixth amendment to the existing Fiscal Year 2019-2020 Annual Action Plan that includes changes to the federal Coronavirus Aid Relief and Economic Security Act (CARES Act) funds awarded by the U.S. Department of Housing and Urban Development (HUD) to the City of San José (City):
 - (1) Approve the following changes relating to the Substantial Amendment to the Fiscal Year 2019-2020 Annual Action Plan to:
 - i. Reallocate Community Development Block Grant CARES Act balance of \$6,836,265 and apply funds to Community Development Block Grant CARES Act eligible uses.
 - (2) Authorize the Housing Department to submit the Substantial Amendment to the U.S, Department of Housing and Urban Development; and,
 - (3) Authorize the City Manager or her designee to negotiate and execute agreements with grantees for the activities identified in these Annual Action Plan amendments and all related contract amendments, extensions, and changes.

SUMMARY AND OUTCOME

This is the sixth amendment to the FY 2019-2020 Action Plan approved by the City Council at the May 14, 2019, Council Meeting. The Action Plan governs the expenditure of entitlement funds and competitive grants that the City receives from HUD. The purpose of the amendment is to spend funds available for COVID-19 response. Although the City is currently in the FY 2022-2023 Annual Action Plan period, it is also necessary to amend the FY 2019-2020 Annual Action Plan for a technical reason. HUD has directed jurisdictions that all new commitments and changes of existing commitments involving CARES Act funding must be done by amendments to the Annual Action Plan that first recognized CARES Act funding. For San José, that is the FY 2019-2020 Annual Action Plan.

This substantial amendment to the Action Plan enables the City to use these identified funds to serve some of the most vulnerable community members impacted by. More specifically, funding will help respond to the community's needs:1) food for homeless, senior, and disabled populations, 2) complete community Wi-Fi projects near Independence High School, Silver Creek High School, and the Seven Trees neighborhood, and 3) provide sanitation services at emergency interim housing.

The funds will allow food service programs to continue. Current contracts will be amended to end on June 30, 2023, though there is an option to extend the agreements into the first quarter of FY 2023-2024. This will allow expenditures to be processed to meet the HUD expenditure deadline of October 2023. These include contracts with Loaves and Fishes, San Jose Conservation Corps, The Health Trust, Catholic Charities of Santa Clara Count, Sacred Heart Community Services, Hunger at Home, Veggielution, and West Valley Community Services. These amendments are warranted due to the critical needs of the community and are permitted by federal government regulations.

As required by the Citizen Participation Plan¹, this is the second public hearing to provide the public an opportunity to comment on the proposed amendment to the Fiscal Year 2019-2020 Action Plan. The first publicly noticed hearing on the proposed amendments was held on February 9, 2023, before the Housing and Community Development Commission.

BACKGROUND

This is the sixth amendment to the City's FY 2019-2020 Action Plan. The purpose of the amendment is to identify critical community programs. The programs will be using available CDBG CARES Act funds.

All entitlement jurisdictions such as San José that receive HUD's federal funds by formula allocation are required to have an adopted Citizen's Participation Plan. San José's Citizen's

Participation Plan describes the efforts that the City will take to encourage its residents to participate in developing federal spending plans. It also requires a public process when a substantial amendment to programs funded in an Action Plan are proposed. According to the City's Citizen's Participation Plan, a Substantial Amendment constitutes a change to a previously adopted Annual Plan that:

- Increases or decreases by the greater of \$100,000 or a 25% change in the amount allocated to a category of funding; or
- Makes a significant change to an activity's proposed beneficiaries or persons served; or
- Funds a new activity not previously described in the Action Plan.

When a proposed change in program funding reaches one of these thresholds, the City must comply with the public process required in the Citizen Participation Plan for substantial amendments, which requires a 30-day public comment period and two public hearings. Public hearings may be conducted virtually.

Accordingly, the City has advertised the availability of the proposed amendments and the opportunity to comment on these amendments on its website five days prior to the hearing, has sent a notice by email to its general distribution list and to its Housing and Community Development Commissioners, and has posted the opportunity to comment on its social media accounts. An email address was provided on the notice where comments can be submitted. In addition, comments will be accepted prior to the hearing via a link on the City Council's agenda webpage as well as by e-mail to the City Clerk (city.clerk@sanjoseca.gov) by 12:00 noon on the day of the hearing. During the hearing, comments can be submitted via eComment on the City's agenda webpage as well as by emailing councilmeeting@sanjoseca.gov and identifying the agenda item number in the subject line.

ANALYSIS

To date, the City of San José has been awarded \$12,841,924 in CDBG CARES Act funding though a formula calculation.

The proposed changes to the City's FY 2019-2020 Action Plan qualify as a Substantial Amendment because it meets the criteria identified below:

- 1. Increase or decrease by the greater of \$100,000 or a 25% change in the amount allocated to a category of funding, or
- 2. Makes a significant change to an activity's proposed beneficiaries or persons served, or
- 3. Fund a new activity not previously described in the Consolidated and/or Action Plan.

The fourth substantial amendment to the FY 2019-2020 Action plan was approved by City Council at the March 23, 2021 Council Meeting². The changes to the CDBG CV (CARES) funding in the FY 2019-2020 Action Plan is provided in Table 2 below:

Proposed Newly Funded Activities

The CDBG CARES Act funds must be used to prevent, prepare for, and respond to COVIS-19. The Housing Department is proposing to amend several food service agreements to extend services to the end of FY 2022-2023. The food distribution team provides delivery of meals to our most vulnerable residents. Seniors, disabled residents, homeless residents, low-income individuals, and low-income families will be served. The agreements will be extended to 6/30/2023 using CDBG-CV (CARES) funds. Additional funding is also required to complete Community Wi-Fi projects in areas surrounding Independence High School. Silver Creek High School and the Seven Trees neighborhood. Funds will also provide sanitation services to emergency housing operations.

After the City Council public hearing, staff will submit the Substantial Amendment and the record of public comments to HUD for approval. The performance outcomes of the HUD funded programs are reported to the public and the City Council in the Consolidated Annual Performance Evaluation Report.

COST SUMMARY IMPLICATIONS

The recommendation actions in the memorandum primarily impacts the CDBG-CV (CARES) fund. In the CDBG CV3 fund, these actions include reallocating CDBG-CV (CARES) funds from FY 2019-2020. If approved, these actions result in no net changes in overall funding. The actions recommended in this memorandum have no impact on the General Fund and meets the CARES requirements. The sixth substantial amendment to the FY 2019-2020 Action Plan will allow the City to reallocate the CDBG CARES funds to address critical needs and to effectively meet the federal deadline to expend the CDBG CARES funds. The expenditure deadline is October 26, 2023.

SUMMARY

The following is a summary and draft language that amends the Fiscal Year 2022-23 Annual Action Plan.

Background

This is a proposed sixth amendment to the City's Fiscal Year 2019-2020 Annual Action Plan. The purpose of the amendment is to reallocate Community Development Block Grant (CDBG) CARES funds to address critical community needs and to effectively meet the federal deadline to expend the CDBG CARES funds.

The City's Annual Action Plan details its funding strategy for the CDBG, Emergency Solutions Grant, HOME Investment Partnership, and Housing Opportunities for People with AIDS programs each year. Annual Action Plans implement a jurisdiction's Five-Year Consolidated Plan and are developed through public input, analysis, and planning. The Action Plan provides spending caps for the different programs or services funded by federal funds.

Substantial Amendment is Needed

All entitlement jurisdictions such as San José that receive Housing and Urban Development federal funds by formula allocation are required to have an adopted Citizen Participation Plan. San José's Citizen Participation Plan describes the efforts that the City will take to encourage its residents to participate in developing federal spending plans. It also provides requirements for the public process to be used when a Substantial Amendment to programs funded in the Annual Action Plan is proposed. Per the City's Citizen Participation Plan, a substantial amendment constitutes a change to a previously adopted Five-Year Plan or Annual Plan that:

- Increases or decreases by the greater of \$100,000 or a 25% change in the amount allocated to a category of funding, or
- Makes a significant change to an activity's proposed beneficiaries or persons served, or
- Funds a new activity not previously described in the Action Plan.

The proposed changes to the City's Fiscal Year 2019-2020 Action Plan qualify as a substantial amendment because they meet the Housing and Urban Development criteria of making a significant change to a program's budget.
