# V. Reports

- A. Chair McCollum shared that he is please to be joining the PAC as public art is one of the most visible things the City does and it contributes greatly to the cultural tapestry of the city.
- B. Public Art director Michael Ogilvie reported that:
  - 1. The Mural Roster Artist Call is open; the deadline is October 24. The call is open only to artists in the counties around the Bay Area. Outreach is in process and includes posts on social media and email out reach to close to 800 area artists.
  - 2. Sonic Runway was a destination on Mexican Heritage Day in September.
  - 3. Artist Bill Vujevich who is creating a mural at Fire Station 14 held a small photo shoot on Saturday September 24 to capture images of children, fire fighters, and a dog for use in the artwork.
  - 4. The Billy deFrank mural is complete. Images were shared.
  - 5. The mural at Mayfair Community Center by artist Jessica Sabogal in tribute to Mayfair teen Keyla Salazar is nearly complete. There will be a dedication event on October 21 in conjunction with the dedication of the new Children's Play Area which is adjacent to the mural.
  - 6. The mural by artist Jason Jagel beneath the VTA overpass adjacent to the BART Station is nearly complete.
  - 7. Restorative replacement of the Weavers Gift stone sculpture is underway. Locating a suitable piece of stone has been a challenge.
  - 8. The foundation for the XO sculpture is going in at the airport; installation of the artwork will soon follow.
  - 9. The restriping of the ground in Parque de los Pobladores is complete, giving a good lift to the site.

Others expressed their support for the design and that they were very glad to see this move forward.
