SUBJECT: REPORT ON CONTRACT AWARD ACTIVITIES UNDERTAKEN BY THE DIRECTOR OF THE ENVIRONMENTAL SERVICES DEPARTMENT PURSUANT TO TITLE 27 OF THE SAN JOSE MUNICIPAL CODE FOR THE PERIOD OF JULY 1, 2022 – DECEMBER 31, 2022

BACKGROUND

This memorandum updates City Council on the awarding of public contracts by the Director of the Environmental Services Department (Director). Title 27 of the San Jose Municipal Code authorizes the Director to award and execute "Public Works Contracts" of \$1.0 million (\$1.2 million when adjusted for inflation per section 27.10.560) or less for those contracts within the Environmental Services Department. San José Municipal Code Section 27.50.560 requires a biannual report of actions taken. This memorandum details the Director's actions taken under this delegation for the period of July 1, 2022 through December 31, 2022. During this reporting period, the Director approved actions to: (1) award construction contracts up to \$1,000,000; and (2) negotiate and execute change orders. Consistent with the Director's authority, there are no unresolved bid protests for these contracts. This activity is summarized in the Attachment.
