SUBJECT: REPORT ON ACTIVITIES UNDERTAKEN BY THE DIRECTOR OF TRANSPORTATION PURSUANT TO TITLE 27 OF THE SAN JOSE MUNICIPAL CODE FOR THE PERIOD OF JULY 1, 2022 – DECEMBER 31, 2022

#### **EXECUTIVE SUMMARY**

Title 27 of the San José Municipal Code authorizes the Director of the Department of Transportation to negotiate and execute certain Public Works contracts, work orders, change orders, permits and other related documents needed to implement a Public Works Project. In accordance with the Municipal Code's reporting guidelines, this memorandum details actions taken under the delegation of authority to the Director of the Department of Transportation for the period of July 1, 2022 through December 31, 2022. During this reporting period, the Director of Transportation approved actions to: (1) award construction contracts up to \$740,000 and (2) negotiate and execute change orders.

This activity is summarized in the Attachment.
