# MINUTES OF THE SAN JOSÉ/SANTA CLARA TREATMENT PLANT ADVISORY COMMITTEE

#### 1. ROLL CALL

# 4. **DIRECTOR'S REPORT**

A. Director's Report (verbal)
CIP Quarterly Status Report: October – December 2022

Environmental Services Department Assistant Director Napp Fukuda reported that the CIP Quarterly Report was included in the agenda packet. A video of the new Headworks 3 emergency overflow basin was presented. Assistant Director Fukuda and interim Regional Wastewater Facility Operations Deputy Director Tim Lewis responded to a question from Committee member Kwok. There were no other questions or comments from the committee or public.

# 5. <u>AGREEMENTS/ACTION ITEMS</u>

A. Report on Bids and Award of Contract for 10228 – South Bay Water Recycling Metering and Pressure Monitoring Improvements Project Phase 1.

## Staff Recommendation to Committee for City Council:

Report on bids and award of construction contract for the 10228 – South Bay Water Recycling Metering and Pressure Monitoring Improvements Phase 1 project to the lowest responsive, responsible bidder, JMB Construction, Inc. in the amount of \$2,681,000, and approve a 10 percent contingency in the amount of \$268,100.

This item is scheduled to be heard at City Council on February 28, 2023.

Environmental Services Department Assistant Director Fukuda advised there was no presentation on this item. There was public comment from Dean Stanford regarding the Director's report video presentation. There was public comment from Joe Weiss on the subject of cyber security. During the vote Committee member Montano commented that she was interested in looking into the subject brought up in public comment.

# 7. STATUS OF ITEMS PREVIOUSLY RECOMMENDED FOR APPROVAL BY TPAC

A. Report on Request for Proposal for Citywide Security Guard Services.

#### Staff Recommendation to Committee for City Council:

Accept the report on the Request for Proposal and adopt a resolution authorizing the City Manager to:

(a)Negotiate and execute agreements with Good Guard Security, Inc. (Chatsworth, CA) for security guard services for the Airport, Transportation, Public Works, Parks, Recreation and Neighborhood Services, Library, and Environmental Services Departments with an initial 14-month term beginning on or about February 1, 2023 and ending March 31, 2024, with a total aggregate compensation for all agreements not to exceed \$9,048,442 for the initial term, subject to the appropriation of funds.

(b)Negotiate and execute amendments and change orders as required to add, delete, or modify services, such as for special events, or to address seasonal variations, budgetary constraints, or unanticipated changes in demand, subject to

the appropriation of funds.

(c)Exercise up to four one-year options to extend the terms of the agreements through March 31, 2028, subject to the appropriation of funds.

(d)Negotiate and execute additional agreements or purchase orders with Good Guard Security, Inc. leveraging the same Request for Proposal to provide security guard services for other City departments as requested, subject to substantially the same material terms and conditions and the appropriation of funds.

This item was deferred from January 31 and is scheduled to be heard at City Council on February 14, 2023.

Monthly Procurement and Contract Activity Reports summarizes the purchase and contracting between \$100,000 and \$1.3 Million for Goods and \$100,000 and \$320,000 for Services.

#### 10. OPEN FORUM

Chair Cohen invited public comment and recognized Committee Member Kwok who requested a report on cybersecurity at the facility. Interim Deputy Director Lewis gave a brief background on cybersecurity at the facility. Chair Cohen stopped any further discussion noting that the item was not on the agenda. Committee member Harkness offered that discussion on cybersecurity issues should not occur in a public meeting and suggested that it may be appropriate to consult with attorneys on whether the subject is suitable for a closed session. Committee member Hardy reiterated concerns about public discussions of cybersecurity matters. Committee member Montano indicated an interest in the subject for future consideration. Public comment from caller with number ending in 396 (later identified as Joe Weiss) offered additional comment on the need for cybersecurity assessments. Dean Stanford spoke about renewed interest in a park on the lands surrounding the facility, invited anyone who was interested to a public State Parks

workshop being held on February 16 in Pleasanton which would include discussion of new parks in San José, SB155 and funding for new state parks. He urged saving the trail around Pond A18 and encouraged consideration of selling the berm land surrounding Pond A 18 to the state for parklands.
