



# **MUNICIPAL ROSE GARDEN**

Municipal Rose Garden is today one of the most attractive of its kind in the world. It is exclusively devoted to shrubs of the rose family and features over 4,000 rose shrubs with 200 varieties represented.

The Municipal Rose Garden is also home to newly hybridized rose and new rose varieties.

This 5 ½ -acre park offers two (2) reservable wedding ceremony areas.

Barbecues and alcohol are NOT allowed in the Municipal Rose Garden.

Commercial photography requires a photo permit.

Reservations are processed at San Jose City Hall on the 9<sup>th</sup> floor, 200 E. Santa Clara St. Monday thru Friday from 8:30 a.m. to 4:30 p.m. The Reservation Office is normally closed during the last two weeks in December and on most holidays. Check or money order must be made payable to the *City of San José*. Cash, VISA, MasterCard, and Discover are accepted.

## **RULES AND REGULATIONS**

**LOCATION:** Municipal Rose Garden is a 5 ½ acre park located in Rose Garden District at Naglee and Dana Avenue.

OPERATING HOURS: Open daily at 8:00 a.m. and closes one-half (1/2) hour after sunset.

**PARKING:** There is no admission. Please follow all on-street parking regulations.

**PHOTO PERMITS:** Photo permits are required for all photo shoots. This includes professional photographers. Permits can be obtained at Reservations Office San Jose City Hall on the 9th floor, 200 E. Santa Clara St., San José, CA 95113. Photo permits are included with wedding reservations.

**VEHICLE ACCESS:** Vehicles (including limousines) are not allowed on service roads, paths or in the picnic areas. Vehicles driving on park service road or paths without a ranger, staff, or supervisor are subject to citation and may be towed at owner's expense.

**RESTROOMS:** The women's restroom is located on the southeast corner of the park.

The men's restroom is located on the northeast corner of the park.

WEDDINGS: Wedding ceremonies are held in the Fountain/Arbor Area (standing only area accommodating 75 guests for 2 hours) or the Stage Area (allowed for seating accommodating 200 guests for 3 hours).

**Electricity** is not available. Reservations for a wedding site must be made in person at the Reservations Office San Jose City Hall on the 9<sup>th</sup> floor, 200 E. Santa Clara St., San José, CA 95113.

# Stage Area- Capacity: 200 (Hours: 3)

- Reservation is in the raised lawn area only **not** in the big field or on the road area.
- Chairs are allowed only on the stage area. Do not put chairs on the service road.
- Arches, arbors, and shade canopies are permitted with an approved ceremony permit.

## Fountain and Arbor Area- Capacity: 75 (Hours: 2)

- Reservation is for the circular fountain area only **not** between rose beds outside of fountain area.
- Chairs, arches, or shade canopies are prohibited.
- Paper runners under the Arbor are allowed.
- Ribbons are allowed on the Fountain fence **only** if they are removed after ceremony.

### **GENERAL RULES:**

- All San José Municipal Codes and State laws apply
- Ceremony sites must be left clean. All decorations must be removed and disposed of properly.
- It is unlawful to damage, deface, vandalize, or otherwise alter City park property.
- Special activities or placing of large equipment must be approved by Park Reservation Staff and Rangers.

# ALLOWED 🔮



- ✓ Birdseed may be used during ceremony.
- ✓ Soloist (harpist, violinist, guitarist)
- ✓ Vendors hired must be paid offsite
- Reservation holder must have approved permit on hand the ceremony date

#### **NOT ALLOWED**



- Alcohol (including beer, wine, champagne, sake, etc.) ×
- × Receptions of any kind
- Amplified sound (including drums, loudspeakers/radios/instruments)
- Confetti or other small decorations
- × Damaging or collecting flowers, roses, petals, or other vegetation
- × Dogs or any other pets
- Electrical use (Electrical outlet is not available for use) Generators are not allowed × at any City park for electrical use.
- × Large groups of musicians
- Littering or unauthorized dumping (including business/residential garbage) ×
- Smoking is not allowed in City of San José Parks X
- × Transfer of money on City of San José property
- Vehicles (including limousines) on service roads, or paths ×
- Weapons (including airsoft/paintball guns) or dangerous instruments
