

Stevens Creek Corridor High-Capacity Transit Collaborative Effort

History

- Beginning in 2017, the jurisdictions of San Jose, Cupertino, Santa Clara, Santa Clara County and VTA formed a multi-jurisdictional group
- Jointly submitted [adopted in 2021] a grade separated high-capacity transit concept along Stevens Creek Boulevard to the Plan Bay Area 2050 process
- Jurisdictions passed resolutions in 2019
- Steering Committee of Elected Representatives established in 2020 as lead in providing policy direction on vision study
- Initial vision study scope was developed and proposed to be amended to VTA's High-Capacity Transit Corridors (HCTC) Study

History Continued

• On July 20, 2020, consensus was found to proceed with funding strategy and study providing vision with illustrative designs to support community engagement and discussion




Proposal

- Due to the halt on work with participating jurisdictions, option to include vision study as an amendment to VTA's HCTC Study has expired
- New vehicle for vision study needed
- The City of San Jose is developing a Multimodal Transportation Improvement Plan (MTIP) for West San Jose.
- The Study Area includes Stevens Creek Boulevard along the shared boundary of our jurisdictions and will make recommendations for Transportation and Streetscape Improvements.
- This project presents a natural opportunity to advance and streamline the Vision Study between participating jurisdictions for the Stevens Creek Corridor while maintaining its Purpose and Expected Outcomes.
