SUBJECT: MULTI-JURISDICTION STEVENS CREEK BOULEVARD COMPLETE STREETS AND TRANSIT PLANNING

### RECOMMENDATION

Adopt a resolution to:

- a. Support the development of A Complete Streets and Near Term Transit Implementation Plan for the Stevens Creek Boulevard corridor to be prepared jointly by the Santa Clara Valley Transportation Authority (VTA) and the Cities of Santa Clara, Cupertino and San José; and High Capacity Transit Service along the Stevens Creek Boulevard corridor currently being planned and investigated in VTA's High Capacity Transit Study and San José's joint Request for Information for an Airport-Diridon-Stevens Creek Transit Connection; and
- b. Authorize the City Manager to assess resources needed to develop these projects.

### **OUTCOME**

The proposed resolution supports the creation of multi-jurisdictional Complete Streets and Near Term Transit planning efforts, the on-going VTA High Capacity Transit study, and the City's Request for Information (RFI) for an Airport-Diridon-Stevens Creek Transit Connection that is investigating new technologies and operational models for grade-separated transit. These efforts will create a multi-jurisdictional vision and implementation plan to create the near and medium term multi-modal transportation systems along Stevens Creek Blvd. needed to meet San José's Envision 2040 General Plan goals.

## **BACKGROUND**

On August 8, 2017, Council approved forming a multi-jurisdiction group comprised of San José, Cupertino, Santa Clara, and Santa Clara County to discuss key regional issues affecting West San Jose, with a focus on transportation and circulation. Vice Mayor "Chappie" Jones and Councilmember Deb Davis were appointed co-chairs. The first meeting of this multi-jurisdictional group occurred on March 25, 2019.

City of San Jose staff have been coordinating with staff from the City of Santa Clara, City of Cupertino and VTA regarding transportation and circulation along the Stevens Creek Blvd. corridor since a working group was formed for this purpose in August 2017. This group has been discussing how to coordinate transportation planning and project delivery along Stevens Creek Blvd., including streetscape improvements to improve bicycle and pedestrian circulation along the corridor, in addition to the need for high-capacity transit as this corridor has evolved into a major health, education, technology industry, shopping, and housing spine in the South Bay.

In 2012, VTA began planning and evaluation efforts for a proposed Bus Rapid Transit service along Stevens Creek Blvd. with a total of 13 stations that would connect the entire corridor from Cupertino to the downtown San Jose Transit Mall. VTA has not pursued this project beyond this planning and evaluation stage to date.

As part of the Metropolitan Transportation Commission (MTC) Horizon Initiative, a Bay Area wide contest in search of innovative transportation concepts, City staff submitted a proposal for a high-capacity transit line from Diridon Station west to Cupertino. The proposal was selected among 94 other transportation projects for consideration to be included in MTC's Plan Bay Area 2040.

San José, with input from the Stevens Creek corridor partner jurisdictions, is developing an RFI for a grade-separated transit service along the same corridor; the RFI will also include a connection to the San José Airport from Diridon station. The RFI will ask the following key questions of potential transit project delivery and service providers.

- Are there new technologies that can provide grade separated transportation solutions?
- Do these new technologies have a significantly lower cost structure than current systems that will enable quick deployment?
- Do these solutions have viable operations plans?
- How will these new technologies construct and deliver services on the Stevens Creek and Airport corridors?

### **ANALYSIS**

The proposed resolution supports the work of the multi-jurisdictional Stevens Creek corridor group and would support the engagement of the City in the development of a Complete Streets and Near Term Transit Plan and VTA's High Capacity Transit Study along with the City of Santa Clara, City of Cupertino, County of Santa Clara, and VTA to bring high capacity transit to the Stevens Creek corridor. The term "High Capacity Transit Service" could include a number of transit technologies, such as light rail, subway, bus rapid transit, aerial conveyances, or other emerging technologies. The resolution recommended for adoption demonstrates the Council's support of "High Capacity Transit Service" along Stevens Creek Blvd. to connect the entire corridor from Cupertino to Downtown San Jose and the growing regional transportation network node of Diridon Station. The proposed resolution supports a grade separated long term solution.

VTA has offered to play a led role in the development of the Complete Streets and Near Term Transit Plan. At the initial meeting of the multi-jurisdiction group on March 25, 2019, VTA requested that all jurisdictions involved officially show their support for the planning efforts.

### **EVALUATION AND FOLLOW-UP**

Staff will coordinate with the District 1 Council office on the final scope of work for the joint Complete Streets and Near Term Transit Implementation plan. Staff will also return to Council with a budget request in support of these efforts once a final scope of work is established. Staff will report to Council in Winter of 2019 on the outcome of the Airport-Diridon-Stevens Creek Transit Connection RFI.

### **POLICY ALTERNATIVES**

Council could choose to not approve the proposed resolution. If the resolution is not approved, Department of Transportation staff will continue working on the Airport-Diridon-Stevens Creek Transit Connection RFI, and VTA will continue work on the High Capacity Transit Study.

SUBJECT: REPEAL AND REPLACE MULTI-JURISDICTION STEVENS CREEK BOULEVARD COMPLETE STREETS AND TRANSIT PLANNING

### **RECOMMENDATION**

Adopt resolutions to:

- (a) Repeal the adopted Resolution No. 79105 adopted on June 4, 2019, City Council item 2.18; and
- (b) Replace it with a new resolution entitled: Multi-Jurisdiction Stevens Creek Boulevard Complete Streets and Transit Planning: (1) supporting a Complete Streets and Near Term Transit Implementation Plan for the Stevens Creek Boulevard Corridor to be prepared jointly by the Santa Clara Valley Transportation Authority (VTA) and the cities of Santa Clara, Cupertino, and San José, and (2) supporting the VTA High Capacity Transit Study and implementation of high capacity transit service along the Stevens Creek Corridor.

## **OUTCOME**

The resolution entitled: *Multi-Jurisdiction Stevens Creek Boulevard Complete Streets and Transit Planning* adopted on June 4, 2019 was not the final draft intended to be adopted. The proposed resolutions would repeal the adopted version and replace it with the correct final version of the resolution.

### **BACKGROUND**

On June 4, 2019, City Council adopted a Resolution No. 79105 entitled: *Multi-Jurisdiction Stevens Creek Boulevard Complete Streets and Transit Planning* (http://sanjose.legistar.com/gateway.aspx?M=F&ID=117f7284-4705-448d-bfe1-7c58a25ef03c.pdf). The version of the resolution that was attached to the City agenda for the item was an early version of the resolution. The clerical error was discovered after adoption. The

changes in the draft adopted and the final draft are considered substantial enough to require repealing the adopted version and formally adopting its replacement.

### **ANALYSIS**

Through a clerical error, the incorrect resolution draft was attached to the City Council agenda and adopted on June 4, 2019. The final version of the resolution intended for adoption encourages consideration of all high capacity transit options and welcomes an open perspective on potential transit solutions for the Stevens Creek Corridor that may emerge through the planning efforts of the participating jurisdictions.

### **EVALUATION AND FOLLOW-UP**

Staff will coordinate with the San José City Council District 1 Office on the final scope of work for the joint Complete Streets and Near Term Transit Implementation plan. Staff will also return to City Council with a budget request in support of these efforts once a final scope of work is established. Staff will report to City Council in winter of 2019 on the outcome of the Airport-Diridon-Stevens Creek Transit Connection Request for Information.

### **POLICY ALTERNATIVES**

City Council could choose to not approve the proposed resolutions. If the resolution is not approved, the version of the resolution adopted on June 4, 2019 would remain in effect.
