SUBJECT: PROPOSITION 218 RATE NOTICING PROCESS FOR MUNICIPAL WATER UTILITY, SEWER SERVICE AND USE CHARGE, STORM SEWER SERVICE CHARGE, AND RESIDENTIAL GARBAGE AND RECYCLING RATE CHANGES BEGINNING FISCAL YEAR 2023-2024

In the first two weeks of April, the City will begin mailing public notices to utility rate payers, advising them of highest potential rate increases based on current information, along with information on how to submit a protest to the potential increase as required by California law (see Article XIIID §6 of the California Constitution, enacted by Proposition 218). This year, the City will issue notices for the following utilities: San José Municipal Water System, and Residential Garbage and Recycling. There will be no change to the Sewer Service and Use Charge or Storm Sewer Service Charge rates in Fiscal Year 2023-24. Based upon currently available information, proposed rate increases are necessary to ensure that utilities maintain fiscal health and continue to provide safe and reliable service.

To allow for City Council consideration of rate changes at public hearings on June 6, 2023, the City must provide notice of the proposed rate increase in Spring 2023. This schedule allows sufficient time for the 45-day notice period required under State law before the public hearings to consider the proposed rate increase. Details on the rate increase proposals for the subject utilities are discussed below. This noticing process requires the City to prepare and mail 246,000 notices to Residential Garbage and Recycling, and Municipal Water rate payers. No notice will be prepared for the Sewer Service and Use Charges or Storm Sewer Service Charges for Fiscal Year 2023-24. Notices are provided to utility rate payers in five additional languages including Spanish, Korean, Vietnamese, Chinese, and Tagalog on the Environmental Services Department Proposed Rate Change webpage at SanJoseca.gov/RateNotices. Translations will be available on April 5, 2023.

San José Municipal Water System Rates

Municipal Water System purchases, treats, and delivers an average of 15 million gallons of drinking water per day to residences and businesses in the service areas of Alviso, North San José, Evergreen, Edenvale, and Coyote Valley. The system includes pipelines, pump stations, fire hydrants, storage reservoirs, wells, and water meters, as well as facilities and processes required to comply with all state and federal drinking water standards. Changes to water rates are primarily related to the projected increased cost of wholesale water from the Santa Clara Valley Water District and the San Francisco Public Utilities Commission, by 15% and 11.6% respectively, and drought-related impacts on the water supply and usage. Additional, smaller changes to costs are included to maintain minimum operating reserve levels and infrastructure improvements.

Public notices will be mailed to approximately 26,000 account holders in the Municipal Water System service area, advising them of a maximum proposed rate change for potable water (see Attachment A for a copy of the public notice). The notice also advises the customers of their right and the procedure to protest the rate increase. Mailing the notices April 5, 2023 allows sufficient time for a 45-day protest period for notice recipients prior to the public hearing and City Council consideration of increased rates on June 6, 2023.

The notice includes a schedule of the maximum proposed potable rates and charges, a sample bill calculation, and average monthly bills based on the maximum proposed rates and charges. Any updated water rates approved by City Council would become effective July 1, 2023. Municipal Water System rates were last increased July 1, 2022. The proposed rates and charges reflect the current costs of providing water service to specific customer classes, service areas, and pressure zones. For the North San José/Alviso service areas, the rates listed on the notice result in an approximately \$17 or 13% increase to an average residential monthly bill, whereas in the Evergreen/Edenvale service area, the increase is approximately \$16 or 15% which, again, is primarily driven by wholesaler water costs established by the relevant wholesale agencies.

Pursuant to Council Resolution 79111 (continuing in effect Resolution 68377), recycled water rates increase automatically based upon wholesale water increases. To increase public awareness, the Municipal Water System will provide outreach to recycled water customers to notify them of this scheduled increase.

Residential Garbage and Recycling

The Integrated Waste Management program provides residential and commercial garbage and recycling services. Residential Garbage and Recycling rates are set to cover the expenses of providing these services for approximately 220,000 residential property owners in the City. Staff regularly reviews the program fund revenues and expenditures and forecasts the rates necessary to implement and maintain City Council-approved services, programs, and activities related to residential solid waste.

Public notices (will be mailed to residential property owners, advising them of residential rate increase proposals for garbage, recycling, and yard trimmings services starting July 1, 2023. This notice (see Attachment B for a copy of the public notice) will advise them of proposed rate increases and their right to submit a protest to the increase as required by California law (Proposition 218). Mailing the notices April 5, 2023 allows sufficient time for a 45-day protest period for notice recipients prior to the public hearing and City Council consideration of increased rates on June 6, 2023.

For Fiscal Year 2023-24, the City is recommending a Residential Garbage and Recycling rate increase of up to 4% for single-family dwelling and up to 2% for multi-family dwelling rate payers. Additionally, the City is recommending a maximum rate increase of 18% (or an additional \$1.05 per month) for the optional single-family dwelling subscription yard trimmings cart, to cover the increased cost of providing the service. Residential Garbage and Recycling rates were last increased in Fiscal Year 2022-23. The recommended rate increases are necessary to fund contractual cost increases due to an average increase of 5.74% in the Refuse Rate Index, which covers cost of living adjustments and increased operational costs for waste haulers. The recommended rate increase will also fund programmatic improvements including the addition of a new recycling contamination reduction team, converting two enforcement staff from limit dated to permanent status, and contractual services support for a garbage cart study.

Sewer Service and Use Charge Rates

For the sanitary sewer, no rate increase is proposed for Fiscal Year 2023-24. Rates were last changed in Fiscal Year 2022-23 when the City Council adopted a total 9% revenue adjustment. Sewer Service Use Charge rates are paid by residential, institutional, commercial, and industrial users of the sanitary sewer system. The charge covers costs associated with the San José-Santa Clara Regional Wastewater Facility and San José's 2,200-mile sewage collection system, including operations and maintenance; capital and equipment improvements; and administration. The Municipal Code Section 15.12.450 restricts this revenue to "the acquisition, construction, reconstruction, maintenance, and operation of the sanitary sewer system of the City of San José, as well as the principal and interest on any bonds, loans, and advances for the construction of the system."

Sewer Service Use Charge rates are based on the volume of flow and the strength of the wastewater from residential, commercial, institutional, and industrial properties. Flow is measured as the average wastewater discharge, and strength is measured in terms of biochemical oxygen demand, suspended solids, and ammonia. The rate structure was designed to apportion the cost of wastewater treatment services to properties in proportion to their relative contribution of flow and strength to the system. This structure is based on the State Revenue Guidelines and allows rates to reflect the costs of providing service to residential and non-residential properties. Rates are assigned by groupings, based on the type of use. Residential customers are assigned a flat rate. Non-residential customers are assigned a rate based on the volume of flow that is calculated as an average of their winter water usage in addition to their discharge strength. A

small number of large industrial users or dischargers are billed on a monthly basis based on actual wastewater flow and discharge strength. No public notices will be mailed by the City for Fiscal Year 2023-24.

Storm Sewer Service Charge Rates

For the storm sewer, no rate increase is proposed for Fiscal Year 2023-24. Storm Sewer rates remain at 2021-22 levels, unchanged since 2011-2012. The Storm Sewer charges provide funding for the maintenance of the storm sewer system; to improve the quality of the City's storm and surface water runoff to meet increasing federal, State, and regional regulatory requirements; and to rehabilitate aging system infrastructure. In order to protect water quality in local streams and the South San Francisco Bay, the National Pollutant Discharge Elimination System stormwater permit requires the City to implement activities and controls to prevent pollutants from entering the storm sewer collection system and receiving waters.

Conclusion

Public hearings to review the protests received as part of the Proposition 218 process will be conducted at the City Council meeting on June 6, 2023. Proposed utility rate changes for Fiscal Year 2023-24 will be brought to City Council for consideration as part of the annual budget process in May and June 2023.

NOTICE OF PUBLIC HEARING: PROPOSED CHANGES AND ADOPTION OF POTABLE/DRINKING WATER RATES

On June 6, 2023, at 1:30 p.m., the San José City Council will conduct a public hearing on proposed changes to the San José Municipal Water System (SJMWS) potable/drinking water rates and charges. The hearing will be held at the City Council Chambers, 200 East Santa Clara Street, San José, California 95113. Discussion on rates will occur when the matter can be heard after the start of the meeting. City Council meetings are hybrid and may be attended either virtually or in-person. For information on participating at a City Council meeting, go to the following URL: www.SanJoseCA.gov/CivicCenterTV.

At the hearing, the City will be considering and approving potable rates, water meter charges, zone charges, and private fire line charges (collectively "Water Rates") starting fiscal year 2023-24 (July 1, 2023 to June 30, 2024). Water Rates are paid by residential, commercial, and industrial customers. Proposed Water Rates and sample bill calculations are on the following pages.

Reason for the Proposed Update

SJMWS provides an average of 15 million gallons of drinking water per day to residences and businesses in the service areas of Alviso, North San José, Evergreen, Edenvale, and Coyote Valley. The system includes pipelines, pump stations, fire hydrants, storage reservoirs, wells, and water meters, as well as facilities required to comply with all state and federal drinking water standards. Changes to Water Rates are primarily related to the projected increased cost of wholesale water that SJMWS purchases from Valley Water and San Francisco Public Utilities Commission, by 15% and 11.6% respectively, and drought-related impacts on the water supply and usage. Additional, smaller changes to costs of operating and maintaining the system are included for planned infrastructure improvements.

The Water Rates have two charges: those to recover fixed costs (meter charges) and variable costs (quantity rates). Customers will continue to be billed a flat service charge based on the size of the water meter (Table 1), as well as a quantity charge per unit of water used (Table 2). The proposed quantity rates reflect the cost to supply water to customers within each service area and within elevation zones in the Evergreen/Edenvale service area. Customers with a dedicated fire service will also pay flat service charges as shown in Table 3.

The Water Rates reflect the projected costs of providing water service to specific customer classes and service areas. Proposed quantity rates include one rate for each service area/zone, which reflects the difference in the costs of wholesale water provided to each service area. Proposed meter charges reflect the costs of service to each meter class.

Important Deadlines

To protest the proposed Water Rates, you must follow these rules for your protest to be included in the official tally presented to the City Council; if there is a protest of the majority, the City Council will not adopt the increase:

- Written protests must be received by the City prior to the close of the public hearing on June 6, 2023.
- You must indicate your name and the service address of the property(ies) you own or rent that is/are subject to the proposed rate adjustment.
- *Written* protests may also be submitted to the Office of the City Clerk before the public hearing in the form of a letter, fax, or email:

Billing Impacts

The proposed Water Rates are shown on Tables 1 and 2. The zone that indicates which charges apply to your service address is indicated at the top of the letter that is attached to this notice. If the City Council adopts the rates as proposed, the impact to your bill can be calculated as shown in the examples below:

Example Water Bill Calculations Comparing Current and Proposed Rates

Water Bill Amount (without utility tax) = Meter Charge + (Quantity x Rate per HCF)

Residential Example in Evergreen Zone 5/6:

Monthly Usage: 13 HCF Meter Size: 3/4-inch

Current Rate: \$35.37 + (13 HCF x \$6.81) = \$123.90**Proposed Rate:** \$38.19 + (13 HCF x \$7.91) = \$141.02

Non-Residential Example in North San José:

Monthly Usage: 100 HCF

Meter Size: 2-inch

Current Rate: \$162.14 + (100 HCF x \$7.01) = \$863.14**Proposed Rate:** \$175.11 + (100 HCF x \$8.07) = \$982.11

Actual impacts to your bill will depend on service area, meter size, and the amount of water you use.

Calculations of example bill impacts are shown in Tables 4 and 5 for residential and industrial customers, respectively. Meter Charge and Quantity Charge are included in all example bill amounts. Example monthly residential bill is based on a 3/4-inch meter and usage of 13 HCF. Example monthly industrial bill is based on a 6-inch meter and usage of 600 HCF.


Where Your Dollar Goes*

Most ratepayer money goes to purchasing high-quality drinking water from Valley Water and the San Francisco Public Utilities Commission (SFPUC). Valley Water and the SFPUC are both raising their prices. Valley Water's expenses are increasing due to rising project costs and water supply-related emergency water purchases. Still, SJMWS's water costs only about a penny per gallon for residential customers.

Attachment B

Reason for Rate Changes

Revenues from the proposed rates pay for residential collection and processing of garbage, unlimited recycling and yard trimmings, motor oil and oil filter recycling, and the unlimited Junk Pickup Program. Rates for these services were last increased in July 2022. These changes are necessary to cover the increased cost of the contractors providing the services, including extra costs related to garbage and other non-recyclables in recycling carts. The residential garbage and recycling system is based on full cost recovery from ratepayers and is not subsidized by the City's General Fund.

Effective Date of Rate Changes

If the City Council approves rate changes at its June 6, 2023, meeting, the new rates and rate additions will take effect July 1, 2023 for both single-family and multi-family properties unless otherwise indicated above. If the Council does not approve the proposed rate changes, current rates will remain in effect. For assistance in determining the cost of the proposed rate adjustments to you, please call the City of San José Customer Contact Center at (408) 535-3500.

Rate Changes

Single-Family

Reason for Rate Changes

Revenues from the proposed rates pay for residential collection and processing of garbage, unlimited recycling and yard trimmings, and the unlimited Junk Pickup Program. Rates for these services were last increased in July 2022. The residential garbage and recycling system is based on full cost recovery from ratepayers and is not subsidized by the City's General Fund.

Effective Date of Rate Changes

If the City Council approves rate changes at its June 6, 2023, meeting, the new rates and rate additions will take effect July 1, 2023 for both single-family and multi-family properties unless otherwise indicated above. If the City Council does not approve the proposed rate changes, current rates will remain in effect. Rate Changes
