In District 3, there are business districts that have a deficit of shade due to being paved over. Cutting the concrete along Calle Willow Business District and Luna Park will beautify the neighborhood and help the environment. The goal is to beautify streets and give life to underserved communities. Cutting the concrete allows a tree to be planted which would provide a myriad of benefits such as shade from the elements, entice people to get out of their cars, and explore the small businesses along the corridor.

Calle Willow: After a site assessment, it was determined that there is no room for new tree wells due to existing infrastructure and the presence of utilities. DOT instead proposes to remove some of the existing trees and grates and improve the soil conditions to enhance planting space for trees.

- Plant 15 trees = \$15,000 (Unit cost per 15-gallon tree + 3 years watering, pruning and maintenance = \$1,000)
- Tree and grate removal + soil improvements = \$5,000
- Additional 25% contingency = \$5,000

Calle Willow TOTAL = \$25,000

*NOTE: There is no ongoing maintenance cost because once established, the tree maintenance will be the responsibility of the adjacent property owner per CSJ municipal code.

2023-2024 Proposed Budget BUDGET DOCUMENT COST ESTIMATE REQUEST

Luna Park: Hedding St. and Mission St. (from 12th to 14th St)

- Plant 51 trees + establishment = \$51,000 (Unit cost per 15 gallon tree + 3 years watering, pruning and maintenance = \$1,000)
- Six tree wells @ \$300 each = \$1,800 (Unit cost per 5'X5' concrete cut (25 sq ft) @ \$12/sq ft = \$300 per new tree well)

Luna Park TOTAL = \$52,800

*NOTE: The bulk of the new trees in the Luna Park area will be on Mission St., in the residential areas. Hedding was also deemed infeasible due to lack of suitable planting space for new trees. The trees can be planted by the City but will ultimately be the responsibility of the adjacent property owner per CSJ municipal code.
