RECOMMENDATION

Modify the City Manager's 2023-2024 Proposed Budget to incorporate the following budget proposal, including any required funding allocation adjustments.

Proposal

Program/Project Title: Blossom Hill/Leigh – Crosswalk/intersection safety improvements

Amount of City Funding Required: \$105,000

Proposal Description, including the reason for the need and anticipated outcomes (Please describe how the proposal will affect services for San José residents, community groups, businesses, etc.):

Blossom Hill Road is a Vision Zero Priority Safety Corridor, a roadway with a disproportionate number of fatal and severe crashes. The signalized intersection at Blossom Hill Rd and Leigh Av is shared jurisdiction between San José and Los Gatos. In March of 2023, the community was devasted by the tragic and preventable death of a pedestrian at this intersection. To reduce vehicle speeds and improve safety, the following recommended improvements should be funded:

- a. <u>Install one (1) speed radar sign on Blossom Hill Road, near Belgatos Road, facing the westbound direction.</u>
- b. Add retroreflective yellow back-plates to all traffic signal heads and upgrade existing 8-inch traffic signal heads to 12-inch on Blossom Hill Rd at Leigh Av, Harwood Rd, and at Camden Av.
- c. <u>Enhance all existing standard crosswalk striping to high visibility striping at Blossom Hill Rd</u> & Leigh Av, and at Blossom Hill Rd & Camden Av.

- d. Install pavement edge line striping on Blossom Hill Rd & Camden Av.
- e. Conduct a feasibility study for a potential lane reduction (4 to 2 through lanes) on Blossom
 Hill Rd between Camden Av and Meadowbrook Dr. If the lane reduction is feasible, it can be
 implemented as part of the future Pavement Maintenance Program subject to outreach to
 the greater community.

<u>Due to this intersection and the Blossom Hill Rd corridor being joint jurisdiction of the City of San José and the Town of Los Gatos, all improvements should be coordinated between the two agencies.</u>
