RECOMMENDATION

Approve the proposed 2023-2024 funding allocations for arts and cultural development grants for a total amount of \$4,139,560.

BACKGROUND

Fifteen percent (15%) of total annual Transient Occupancy (TOT) revenue is used to fund cultural arts grants in the Office of Cultural Affairs (OCA) division of the Office of Economic Development and Cultural Affairs. Per the Municipal Code, allowable uses of these funds include arts programs, grants, and services as well as OCA operating costs (including staff, administration, and public art maintenance). Each year, grant awards are recommended based on projected TOT revenues and a competitive application-based peer review process. As outlined in the 2023-2024 Proposed Operating Budget, TOT revenue estimates remain significantly lower than pre-pandemic levels. Due to the continued impact of COVID-19 on both TOT revenues and the cultural arts sector, grant recommended in the 2023-2024 Proposed Operating Budget.¹ The purpose of this memorandum is to outline the recommended grant awards in the 2023-2024 *Cultural Funding Portfolio: Investments in Art, Creativity, and Culture.*

¹ The 2023-2024 Proposed Operating Budget includes an allocation of \$1.0 million for the Small Business Recovery – Supplemental Arts + Cultural Funding City-Wide Expenses appropriation, as well as \$5.4 million from the Transient Occupancy Tax Fund for OCA-managed initiatives, which include the arts and cultural development grants recommended in this Manager's Budget Addendum.

ANALYSIS

Each year, in tandem with the development of the Proposed Operating Budget, the OCA develops recommendations for the allocation of funds for arts and culture grants. Among the most significant of the OCA's programs are the competitive grant programs that comprise the *Cultural Funding Portfolio: Investments in Art, Creativity, and Culture* which include Operating Grants; Festival, Parade, and Celebration Grants (FPC); and take pART Grants. These grants are aimed at promoting artistic vibrancy, economic development, and cultural diversity in San José. These grants also support broad-based, community-wide participation in a wide range of arts experiences across San José, including expressions of multicultural traditions of San José's diverse population.

The OCA releases annual guidelines and criteria for its grant programs that comprise the *Cultural Funding Portfolio*. Notices of the grant opportunities are publicized through multiple channels including the City's website, OCA's contact list and social media channels, community partners and in several local newspapers published in English, Spanish and Vietnamese. Each spring, peer review panels evaluate and score applications based on the guidelines and criteria. Peer review panels are open to the public and comprised of a diverse mix of Arts Commissioners, multidisciplinary nonprofit arts and culture professionals, and community representatives. The grant applications for these programs are usually accepted in January/February with public grant review panels held in March/April, leading to grant recommendations to the Arts Commission in May that are voted on by the City Council as part of the City's Operating Budget.

Of the 94 recommended grant awards listed in Attachment A, 44 (47%) of the grants are for organizations, programs or events that specifically serve San Jose's BIPOC (Black, Indigenous, People of Color) communities. This reflects a 3% increase in comparison to 44% of 2022-2023 arts and culture grants that specifically serve BIPOC communities.

Arts and Culture Sector Recovery and Creative Economy

The COVID-19 pandemic resulted in the closure or art organizations, resulting in a significant loss of earned income from programming, admissions, and fundraising events. With the continued reopening of public life, it will take time for San José's arts and culture sector to recover fully. While many San José residents are engaging in arts and cultural offerings and events, audiences and earned revenues have not returned to pre-pandemic levels for many arts and cultural organizations.

To support the arts and cultural sector in 2023-2024, the Proposed Operating Budget includes \$1.0 million of additional one-time funding from the General Fund for cultural grants as part of the City's continued community and economic recovery efforts. The total of \$4,139,560 in proposed art and culture grants in these three programs reflects a 9% increase over the \$3,795,726 awarded in 2022-2023. OCA also plans to continue technical assistance to support the arts and cultural ecosystem through the recovery phase.

Additionally, any savings from 2022-2023 allocations for cultural grants and administrative costs will be rebudgeted into 2023-2024 for OCA-managed programs as part of the 2022-2023 Annual Report for reinvestment into the San José arts and culture sector.

At its May 16, 2023 meeting, the Arts Commission reviewed the proposed 2023-2024 grant recommendations under the OCA's *Cultural Funding Portfolio*. It is recommended that the Mayor and Council approve the 2023-2024 grant award recommendations listed in Attachment A.
